MEANING OF THE WOMEN@SECOND (PW) LOGO

The chain is made of individual links of different shapes and sizes, to symbolize how each woman is different. It forms a circle of unity, but because a chain can also mean imprisonment, this chain is broken, expressing women freed by faith.

The three figures, with no distinctive features, represent women of all ages and racial/ethnic backgrounds, a community of women in Christ. As "the forgiven" these women rising from the Bible illustrate serving, studying and praising God.

The design suggests a triangle within a circle — Trinity and Unity.

BYLAWS OF THE WOMEN@SECOND

*In the Second Presbyterian Church
Indianapolis, Indiana*

ARTICLE I - NAME

This organization shall be called Women@Second (PW) in the Second Presbyterian Church of Indianapolis.

ARTICLE II - PURPOSE

Forgiven and freed by God in Jesus Christ and empowered by the Holy Spirit, we commit ourselves: to nurture our faith through prayer and Bible study, to support the mission of the church worldwide, to work for justice and peace, to build an inclusive, caring community of women that strengthens the Presbyterian Church (U.S.A.) and to be witnesses to the promise of God's kingdom.

ARTICLE III - MEMBERSHIP

All women members of Second Presbyterian Church are considered the Membership. They become active when they accept the Purpose of Women@Second (PW) and are willing to contribute through participation, service, prayers, or gifts for the work of Women@Second (PW).

Among the ongoing programs of Women@Second (PW) are small groups that gather regularly to provide an inclusive, caring community of women. Each group shall consider itself an integral part of Women@Second (PW) and will be encouraged to use the resources of Women@Second (PW) to strengthen this connection.

ARTICLE IV - OFFICERS

Section 1 — Elections and Installation

Elected officers shall be a Moderator, a First Vice-Moderator, Second Vice- Moderator(s), a Secretary, a Treasurer, a Mission and Benevolence Coordinator, Local Mission Coordinator(s), a Membership Coordinator, Program Coordinator(s), Communications Coordinator(s), and a Search Committee Chair. The elected officers are known as the Executive Committee (see Article VI, Section 1).

These officers shall be elected for a two-year term with the exception of the Second Vice-Moderator(s). Second Vice-Moderator(s) will be elected every year.

None shall be eligible for more than two full consecutive terms in the same office.

No Second Presbyterian Church staff will be eligible to serve as an officer.

All officers must be a member of Second Presbyterian Church.

Officers shall be elected in two groups: the Moderator, the Second Vice-Moderator(s), the Secretary, the Mission and Benevolence Coordinator, a Local Mission Coordinator, a Program Coordinator, a Communications Coordinator, and three Search Committee members shall be elected in the odd years. The First Vice-Moderator, the Second Vice-Moderator(s), the Treasurer, a Local Mission Coordinator, the Membership Coordinator, a Program Coordinator, a Communications Coordinator and three Search Committee members shall be elected in even years.

Officers shall be elected at a Women@Second (PW) Coordinating Team meeting and installed in the spring. The transfer of leadership takes place at a Women@Second (PW) Coordinating Team meeting in the spring.

ARTICLE V - W@SCT AND EXECUTIVE COMMITTEE

Section 1 - Composition

W@SCT shall consist of all elected officers of Women@Second (PW) and a representative from Session, Deacons, and from each Women@Second (PW) group. W@SCT shall be responsible for the work of Women@Second (PW).

The Executive Committee shall consist of the Moderator, the First Vice-Moderator, the Second Vice-Moderator(s), the Secretary, the Treasurer, the Benevolence and Mission Coordinator, the Local Mission Coordinator(s), the Membership Coordinator, the Program Coordinator(s), the Communications Coordinator(s) and the Search Committee Chair. The Executive Committee is empowered to act on affairs of Women@Second (PW) between regularly scheduled W@SCT meetings.

Section 2 - Liaisons

The pastoral liaison, the liaison from the Session and Deacons, all other liaisons who may be assigned to Women@Second (PW) and the remaining five members of the Search Committee shall be members of W@SCT but without voting privileges.

Section 3 - Meetings

Meetings may be called as needed by the Moderator or by any two members of the Executive Committee.

Section 4 - Quorum

A majority of the Executive Committee must be in attendance to constitute a quorum either for W@SCT or Executive Committee meetings.

ARTICLE VI - DUTIES OF ELECTED OFFICERS

Each officer shall maintain files and records to pass on to their successor. Each responsibility is described in the Standing Rules.

ARTICLE VII - GATHERINGS

Women@Second (PW) shall hold a Gathering each calendar year with an emphasis on the traditional Praise Gathering and honoring Sally McFarland through the Sally McFarland Fund.

ARTICLE VIII - STANDING COMMITTEES

The Budget Committee shall consist of the Treasurer, the Mission and Benevolence Coordinator, and the Local Mission Coordinator(s) and others as appointed by the Treasurer. The Moderator and the pastoral liaison will serve as ex officio members.

The Mission and Benevolence Committee shall consist of the Mission and Benevolence Coordinator, the Treasurer, and the Local Mission Coordinator(s) and Second Vice Moderator(s). The Moderator and pastoral liaison serving as ex officio members.

The Women@Second (PW) Program Committee shall consist of the Program Coordinator(s), the Public Relations Coordinator(s), the First Vice-Moderator, the Treasurer and others as appointed by the Program Coordinator(s). The Moderator and pastoral liaison will serve as ex officio members.

ARTICLE IX - RELATIONSHIPS

Women@Second (PW) in the Congregation - Women@Second (PW) in the Second Presbyterian Church shall be under the jurisdiction of the Session of Second Presbyterian Church of Indianapolis, Indiana.

Women@Second (PW) in the Synod - Women@Second (PW) in the Second Presbyterian Church is a member of Presbyterian Women in the Synod of Lincoln Trails.

PW in the P.C. (U.S.A.), Inc. - Women@Second (PW) in the Second Presbyterian Church is a member of and shall support the work of Presbyterian Women in the Presbyterian Church (U.S.A.), Inc.

ARTICLE X—125TH PRAISE OFFERING ENDOWMENT FUND

This fund will be an additional mission-giving resource and be separate from the budget. The Women@Second Mission and Benevolence Committee will determine how the 125th Praise Offering Endowment is spent, with input and recommendations from the 125th Praise Offering Endowment Fund Representative and/or Committee and with the approval of W@SCT. This spending allocation will be consistent with that of SPC's Endowment spending policy.

There may be special consideration for opportunities beyond the annual "draw" to spend down the 125th Praise Offering Endowment Fund. With the Explicit understanding that the corpus never drop below the original \$125,000.

ARTICLE XI—SALLY MCFARLAND PROGRAM FUND

The Sally McFarland Fund, which is invested and controlled by the church's Endowment, will provide to Women@Second (PW) an annual amount that will be used toward speaker costs. This amount will be calculated by the church's Director of Financial Services and Women@Second (PW) Treasurer. Women@Second (PW) can transfer the amount to its Program Fund.

ARTICLE XII—DR. JOAN B. MALICK SEMINARY SCHOLARSHIP FUND

The Dr. Joan B. Malick Seminary Scholarship Fund was established to benefit seminary students under the care and concern of our Session, qualified recipients from McCormick Seminary, or seminary students under the care and concern of Whitewater Valley Presbytery. The Malick Seminary Scholarship Fund Committee will select the recipients with the approval of W@SCT annually. This Fund will be invested through the church's Endowment; however, Women@Second (PW) retains all control. The maximum scholarship total shall not exceed ten thousand dollars (\$10,000) per year.

ARTICLE XIII - AMENDMENTS

Amendments to the Bylaws must be approved by the Executive Committee before being presented, in writing, and voted upon at a Women@Second (PW) Gathering. A two-thirds majority vote of those present at the Gathering is needed to amend the Bylaws.

ARTICLE XIV - AUTHORITY

Robert's Rules of Order, Revised, shall be the authority of all procedures not covered by these Bylaws.
